OLD BUSINESS:

Fire Protection Tax Increase Request

Chairman Brown recognized Ryan Romberger, Administrative President. The Fire Company is asking the Supervisors consideration to increase the fire protection tax millage from .47 to .70 mills beginning 2021. There has not been a fire protection tax increase for over 20 years. With expenses increasing, the budget projects a shortfall in cash unless a tax increase is implemented. Explored avenues for other alternatives to increase fire protection funding, noting the tax increase would have a minimal impact on most homeowners and also noting a tax increase would create a hardship for some property owners. After discussion, a motion was made by Supr. Stout to approve to enter into a four-year agreement with Reliance Hose Company and approve to increase the fire protection tax from .47 mills to .70 mills,

effective 2021, second by Supr. Stadheim. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.

Solar Farm Development Research

Solicitor Kerwin expressed concerns of who will be the responsible party to clean up the sea of units at the end of their usefulness.

Alternate Route Logging Trucks

Janitorial Service Rates

It was noted a two percent increase for services was applied by the contractor, as per the terms of the Janitorial Agreement.

Emergency Management Coordinator, David Shelleman submitted a Local Advanced Certification Form for signature.

As per the last meeting, a letter of appreciation addressed to the Upper Dauphin Area School District Board was presented to the Supervisors for signature.

SOLICITOR REPORT:

Solicitor Kerwin advised Walmart is appealing their tax assessment. Upon the recommendation of Solicitor Kerwin, a motion was made by Supr. Brown to approve the Solicitor to pursue Walmart's appeal with the school district, second by Supr. Stout. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.
