The Program is intended to make real differences with respect to local groundwater and surface water quality to meet Chesapeake Bay plan goals. It is the consensus of the Supervisors to table further discussion until their last meeting in December and during the interim to consider the investment.

The relationship manager at Gratz Bank is obtaining information, to begin the application process to secure a loan for the Roof Over Project.

Meeting (Broadband Expansion)

Supr. Stoneroad attended a meeting regarding the broadband build-out proposal between Comcast and Dauphin County. It was mentioned during the meeting that there will be build-out in most of the Northern Dauphin Townships.
