The Washington Township Board of Supervisors regular meeting was held at the municipal building on November 1, 2022.

Chairman, Benjamin Brown called the meeting to order at 7:00 PM, followed by the Pledge of Allegiance and a moment of silence.

#### **BUSINESS ITEMS ADDED:**

A motion was made by Supr. Stadheim to add the following agenda item: Request for on lot sewage planning exemption (Kratzer), second by Supr. Stoneroad. Motion carried.

#### **PUBLIC COMMENTS:**

Chairman, Benjamin Brown called for public comments.

Chairman Brown recognized Debra Boyer. Debra Boyer asked what the township used to spray along SR209 (road bank along Oak Street) and Nursery Road on September 29<sup>th</sup> or 30<sup>th</sup>. Ms. Boyer commented her honeybees are all dead and believes her loss is due to the spray odor that lingered in the air for a few days. Ms. Boyer is asking for \$1150.00 in compensation for her loss. After a brief question period and noting the Township has never experienced this sort of claim in the past, it is the consensus of the Supervisors to ask the Roadmaster to conduct research on this matter prior to taking any action.

# **MINUTES:**

#### Financing - Roof Over Project

Link Bank, a division of the Gratz Bank supplied two separate options pertaining to the terms and conditions of the \$200,000.00 loan to assist with the expenses of the municipal building roof replacement. After consulting with Solicitor Kerwin, Supr. Stout made a motion to choose Option 1 – 5 year fully amortizing loan, at a fixed rate of 4.35% Tax Free, second by Supr. Stadheim. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.

# Operations & Maintenance Agreement-Post Construction SWMGT Plan (Shiffer)

Supr. Brown made a motion to approve to sign the Operations & Maintenance Agreement for the Post Construction Stormwater Management Plan contingent upon the two comments provided by the township engineer's October 28, 2022 final review are addressed, second by Supr. Stout. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.

# Janitorial Service Rate

Supr. Stout made a motion to accept the notification of a 2% annual increase for cleaning services, beginning November 2022, as per the terms of Shirley's Deitrichs' Cleaning Service janitorial contract, second by Supr. Stoneroad. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.

#### **Employee Manual**

The employee manual is due for its five-year review. Supr. Stout made a motion to approve the employee manual (full and part time) with no revisions and schedule a full review of the employee manual in five years, second by Supr. Stoneroad. It was noted that revisions will be considered, as needed, during the interim of the next five-year review. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.

#### Register Second Current Building Codes Official

It was noted that Labor & Industry does not have on record the appointment of the township's second building codes official. Supr. Stoneroad made a motion to sign the UCC-29 form that provides the information of the additional BCO, second by Supr. Stadheim. Motion carried.

# **Winter Maintenance Policy**

Supr. Stoneroad made a motion to approve the Winter Maintenance Policy effective November 1, 2022, through October 31, 2023, second by Supr. Stadheim. It was noted there were no revisions to the policy. Motion carried.

#### Request for Planning Exemption Under the Sewage Facilities Act.

It was noted the Township's Official Sewage Facilities Plan shows that the Kratzer subdivision is in an area planned to be served by on lot sewage disposal systems. A motion was made by Supr. Stout to sign the application requesting exemption from the Act 537 planning requirements, second by Supr. Stoneroad. Roll Call Vote: Stoneroad (yes) Stadheim (yes) Brown (yes) Stout (yes) Motion carried.
