Treasurer's Report: In the absence of Treasurer, John Burget, Vice Chairman, Matt Boyer gave the Treasurer's Report as follows: Beginning balance on 12/13/22, \$132,687.71; Deposits \$0.00; Interest, \$5.52; Expenses, \$6,558.87; Balance on 1/10/23: \$126,134.36. With a motion by Dory Kauffman, a second by Scott Klouser and a roll call vote, the Treasurer's report was approved.

Old Business; There was a short discussion concerning a conversation with Township Secretary Sitlinger and Chairman Klouser wherein he reported that due to the increase in salary for the members of the Authority, a 1099 will be now be issued.

Chairman Klouser reported there is nothing new concerning the water line to the sewer plant. He stated he would be making some telephone calls.
