## Annual Maintenance Fee Dauphin County

As per the lease agreement with Dauphin County, the Township is to submit a written accounting of the actual costs of the maintenance services provided to the Magisterial District Judge Office 12-3-01 annually, to Dauphin County by January 15 each year. The Supervisors reviewed an itemized list of the maintenance services totaling \$12,882.80. The Secretary added she needs to confer with the Roadmaster on the maintenance labor provided by the road crew prior to submitting the bill to the county.

## **Cleaning Services**

Quotes for cleaning services were received from Room Service Express (\$210 weekly charge) and Hilary Pogasic Cleaning Service (\$280.00 weekly charge). Supr. Stout made a motion to approve Room Service Express, Inc. to provide the weekly cleaning services to the municipal building, second by Supr. Stadheim. ### Acknowledgement of a Proposed Driveway

It is the consensus of the Supervisors to execute the letter addressed to PennDOT acknowledging the Upper Dauphin Area School District's proposed construction of a minimum use driveway from Church Street.

The Supervisors are not opposed to being included in Dauphin County's Tax Claim Bureau intention to extend a 30-day interest free grace period of unpaid 2024 real property taxes.

The PSATS Unemployment Compensation Group Trust Fund disbursed a **dividend check** in the amount of \$52.24.

Comcast has scheduled a webinar this coming Wednesday to provide information concerning the **Broadband Equity Access and Deployment (BEAD) grant program.** Comcast intends to apply for funding in Dauphin County which would include unserved locations that lie within the potential project area in our Township.
