

# NOTICE OF PUBLIC MEETING AND INTENT TO ADOPT ORDINANCE

Notice is hereby given that the Washington Township Board of Supervisors shall consider for adoption proposed Ordinance No. 2025-02 during their regular scheduled September 16, 2025 meeting, beginning 7 PM at the municipal building located at 185 Manors Road, Elizabethville, Dauphin County, PA 17023. The entire text of proposed Ordinance 2025-02 is as follows:

## ORDINANCE NO. 2025-02

### AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, A SECOND-CLASS TOWNSHIP OF THE COUNTY OF DAUPHIN, COMMONWEALTH OF PENNSYLVANIA, AMENDMENTS TO THE CODE OF ORDINANCES, AND CORRECT TYPOGRAPHICAL ERRORS TO CHAPTER 15, MOTOR VEHICLES AND TRAFFIC.

#### SECTION 1

Now therefore, be it enacted by the Board of Supervisors , after a public meeting duly advertised, Chapter 15 Motor Vehicles and Traffic of the Code of Ordinances, of Washington Township, Dauphin County be amended as follows:

#### Amend §15-205. Traffic Signals at Certain Locations.

**Section 2. Severability.** If any provision, sentence, clause, section, or portion of this ordinance shall be held invalid or unconstitutional by any court or competent jurisdiction, such unconstitutionality or invalidity shall not affect any other provision, sentence, clause, section or portion of this ordinance which shall continue and remain in full force and effect.

**Section 3. Repealer.** All other sections, parts and provisions of the Township of Washington Code of Ordinances shall remain in full force and effect as previously enacted and amended.

**Section 4. Effective Date.** The ordinance shall take effect and be in force five (5) days after its enactment by the Supervisors of Washington Township, County of Dauphin, Commonwealth of Pennsylvania as provided by law.
